## Guidelines to Authors

### Aims and Objectives

**RJU Research Journal** is an innovative, multidisciplinary, multilingual (English, Nepali, Maithili) multicolumn research journal published by Research Center, RajarshiJanak University, Janakpurdham, Nepal. It is dedicated to cover wide spectrum original research papers under following categories:

- **Review Articles:** On any pre-published idea or topic with the latest information and with more than 15 references.
- **Full-Length Papers:** Covering standard write-up span of 10-12 MS Word pages double space typed material with tables and graphs/figs. Photographs up to 4-6, may also be accommodated in black and white (colour photograph to be printed on extra tariff) strictly in the standard format given below.
- **Popular/ General Articles:**[not exceeding 3500 words, 6 display items (tables and figures)] discuss current trends in research in a field that would be of interest to readers outside the field. The articles should include an abstract, introductory paragraph, brief subheads at appropriate places, illustrations that will help a general reader, and references.
- **Research /Short Communications :**( not exceeding 2000 words) contain important new findings that are novel and of fairly broad interest. They should include a brief abstract and an introductory paragraph. **Text should NOT be broken up under subheads.**

### Standard Format of Manuscript Preparation for full-length papers:

- The title should be brief, specific and amenable to indexing. Use title case and bold font. The title should be a direct explanation of the focus of the paper. Do not include any unnecessary descriptors such as “An Analysis of ...” or “A Study of ....”
- The materials should be typed in double space MS Word (font size 12) on one side only of A-4 size paper.
- The pages should be numbered consecutively, starting with the title page and through the text, reference list, tables and figure legends.

- The manuscript should be ordered as follows: Title page, abstract, key words, text, acknowledgements, references, tables, figure legends and figures (one figure per page; the figures should be labelled).
- The title page should contain Title, Authors, Affiliations, and Corresponding author and address.
- Name of the authors: exclude any labels such as Mr., Ms., Dr, PhD....
- One of the names of the authors should be asterisked as the correspondent author to be given in the foot space with email-id. / Mobile number.
- A brief abstract (not more than 150 words) and keywords (not more than 10) should precede the introduction. Separate key words with comma.
- Text: All papers should have a brief introduction. The text should be intelligible to readers in different disciplines and technical terms should be defined. Tables and figures should be referred to in numerical order. All symbols and abbreviations must be defined, and used only when necessary. Superscripts, subscripts and ambiguous characters should be clearly indicated. Units of measure should be metric or, preferably, SI.
- Figures: Line drawings should be roughly twice the final printed size. Primary data should be submitted as far as possible (e.g. actual photographs of electrophoretic gels rather than idealized diagrams).
- arranged serially without alphabetical consideration and superscript in the text as and where mentioned, details not required in the text to save space.
- The manuscript should be submitted 45 days in advance, in one soft copy (CD) prepared in MS-Word / Page maker and two hard copies for mailing to the referees; photographs should be in JPG file (BW) and graphs & tables in Excel file.
- In-text citations: Structure of a citation in the text narratively, with the author's name missing: Title of the Source (Year). In parenthesis, at the end of the sentence, with the author's name missing: (Title of Source, Year). Structure of citation for two authors –  
 In the text, narratively: Last name of Author 1 & Last name of Author 2 (Year)... (page number).  
 In parentheses, at the end of the sentence: (Last name of Author 1 & Last name of Author 2, Year, page number).  
 Citation structure for three or more author: (Last name of Author 1 et al., Year, page number) OR Last name of Author 1 et al. (Year)... (page number).
- References display the full information for all the citations found in the body of the paper. All references should be listed in alphabetical order by the first word in the reference, which

is usually the author's last name. If the source lacks an author, alphabetize the source by the title (ignore A, An, or The).

References of Book and Journal should be written as follows:

Full versions of E- books:

Journal article in print:

Exley, C., Chappell, J. S., & Brichall, J. D. (1991). A mechanism of acute aluminium toxicity in fish. *J. theoretical Biol.* 15(1), 42-47.

General:

At least one of the authors (in a group of 3 co-authors only) must be a member of the RJU Research Journal. The membership can be procured by filling up the form as per any of the subscription options given thereon.

Authors are requested not to plagiarize the pre-published materials in verbatim in order to help us in achieving the quality control of the journal. The editorial board is not responsible for any duplication or dispute in the write-up of the manuscript.
